Co-ops sometimes use small claims court to collect money when members leave owing arrears or a damaged unit, or to pursue monies owing from contractors or third parties. This workshop will walk you through the Small Claims process, discuss the benefits of settling out of court, and advise on best practices. We will also discuss the basics of defending a claim, in the event that the co-op is served.
